

¹ Diameter Breast Height (DBH) means the diameter, in inches, of a tree measured at 4.5 feet above the existing grade. Use the following formula to calculate diameter: $D = C \div \pi$ (3.14159). (Example; $60'' \text{ Circumference} \div 3.14159 = 19.10'' \text{ Diameter}$)

NOTICE TO APPLICANT:

1. A tree survey is required for all new construction.
2. Trees to be saved must be properly barricaded prior to inspection.
3. No site work is to be undertaken until a building permit has been issued.
4. Trees to be removed must be marked with ribbon or similar material which can be easily seen by the inspector.
5. No trees shall be removed until a tree removal permit has been issued.
6. Payment of the application fee does not constitute approval to remove any tree.
7. Tree removal permits issued expire 6 months from the date of approval.
8. If a permit expires a new application is required for tree removal.
9. Trees removed shall be replaced as follows:
 - a. One DBH inch for each DBH inch removed, or
 - b. A replacement fee in lieu thereof as outlined in Table 2 below shall be paid.

I hereby affirm that this application is a true and accurate representation of all the facts concerning the proposed removal of tree(s). I further understand that any deviation from the approved permit will render the permit null and void, and shall constitute a violation of the City of Tarpon Springs Tree Protection and Preservation ordinance.
